

TRUE FOOD YEAR OF TRUE SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN.

SWEEPSTAKES PERIOD: The True Food Year of True Sweepstakes (“Sweepstakes”) begins at 12:01 AM Mountain Standard Time (“MST”) on January 1, 2017, and ends at 11:59 PM MST on February 10, 2017. (“Sweepstakes Period”). The Sweepstakes computer, as determined by Sponsor in its sole discretion, is the official time keeping device for the Sweepstakes.

SPONSOR: Fox Restaurant Concepts, 4455 E Camelback Rd #B100, Phoenix, AZ 85018 (“Sponsor”).

AGREEMENT TO THE OFFICIAL RULES: By participating in the Sweepstakes, all entrants fully and unconditionally agree to and accept these Official Rules and the Sponsor’s decisions which are final and binding in all matters related to the Sweepstakes. Winning the prize (described below) is contingent upon fulfilling all requirements set forth herein.

ELIGIBILITY. Legal residents of the fifty United States and District of Columbia (except in states where prohibited), who are 18 years of age or older are eligible to enter, except employees of Sponsor, and any other organizations affiliated with the sponsorship, fulfillment, administration, prize support, advertisement or promotion and/or their respective agents, affiliates, subsidiaries, and members of their immediate families or persons residing at the same address.

A. Instagram Posting Option. Follow True Food Kitchen on Instagram (@true_food_kitchen) and share a photo of your healthy ingredients or healthy meal while you’re eating on your quest to live well by using the hashtags #YearofTrue and #Entry. For each photo you submit using the promo hashtags, you’ll be entered in the Year of True Sweepstakes. There is no limit on the number of entries, but each entry must be a unique photo. Duplicate entries will be disqualified.

All entries become the property of the Sponsor and will not be acknowledged or returned. Sponsor assumes no responsibility for lost, mutilated, late or misdirected entries. All entry content must be appropriate for all ages. You represent and warrant that you will not submit any content that contains any inappropriate content, for example but not limited to, profanity, defamatory statements, words or symbols widely considered offensive to individuals of any certain race, ethnicity, religious, sexual orientation or socioeconomic groups, threats to any person, place, business, or group or content that infringes on the intellectual property rights of a third party. Sponsor, in its sole and absolute discretion, will determine if an entry violates the guidelines in these Official Rules.

PRIZE AND THE VALUE OF THE PRIZE.

One (1) Grand Prize: Grand Prize winner will receive a \$100 True Food Kitchen credit per month for one (1) year. The approximate retail value (ARV) of the Grand Prize is \$1200.00.

TIMING OF DRAWINGS AND NOTIFICATION TO WINNER. On or about February 17, 2017, Sponsor will conduct a random drawing of all eligible entries received during the Sweepstakes Period to select a provisional Grand Prize. All drawings will be conducted by Sponsor or its designee, the judges of the Sweepstakes, whose decisions are final and binding on all matters related to the Sweepstakes. The provisional winners will be notified by Sponsor via Instagram direct message within three (3) days after the respective drawing. If a provisional winner fails to respond to Sponsor's notification within two (2) days of the message, the provisional winner will be disqualified and a substitute provisional winner will be selected from among the remaining entrant using the process set forth above. The first eligible provisional winner that the Sponsor successfully contacts and who claims the respective prize, and, if requested by Sponsor, completes and returns an Affidavit of Eligibility, Publicity and Liability Release ("Affidavit") within the time period specified on the Affidavit in accordance with these Official Rules will be declared the respective Prize winner.
